Honolulu Community Action Program's executive management team visited Washington, D.C. to

Washington, D.C. to attend a National Community Action Foundation confer-

ence. The team met with Senator Daniel Akaka, Representatives Colleen Hanabusa and Mazie Hirono, and staff of Senator Daniel Inouye's office, to discuss the impact of community action agencies during the recent economic crisis. Through the Community Services Block Grant (CSBG), Head Start and other funding, HCAP and the national network of 1,100 community action agencies manage \$5.6 billion in public and private resources annually. The agencies are instrumental in helping 9.3 million low-income people each year find jobs, provide for their families, and lead productive lives. HCAP's team expressed their appreciation to Hawaii's Congressional delegation's for their unwavering support of CSBG, Head Start and HCAP's many other programs.

Federal funding update

The final federal budget agreement for Fiscal Year 2011 impacted these HCAP programs:

- Community Services Block Grant received a reduction of 3%.
- Head Start increased by \$340 million nation-wide, bringing its annual funding to \$7.5 billion.
- Senior Community Services Employment Program (SCSEP) reduced its budget by 25%.
- Mentoring Children of Prisoners program lost all Federal funding. (Read about the impact on HCAP in "From our Director" on page 2).

Free Tax Help: Working families refunded nearly \$500K

HCAP proudly partnered again this year with the Family and Individual Self-Sufficiency Program (FISSP) to offer free tax preparations to low-to-moderate income working households. The FISSP's 14 partner agencies offer free tax clinics state-wide, assisting thousands of local families with filling their taxes.

The clinics emphasize filing for the Earned Income Tax Credit (EITC) and Child Tax Credits. EITC has been called one of the best asset building and poverty reduction strategies available to low-income, working individuals and families.

Through HCAP's free tax clinics at six sites on Oahu, over 360 households filed their taxes, qualifying for a total of \$497,205 in refunds. Of those, 169 households filed for the EITC, receiving an average of \$1,366 in tax credits per household.

The Free Tax Help program is coordinated by the Hawaii Alliance for Community-Based Economic Development (HACBED) and the Internal Revenue Service.

Success Story!

Rudy and his wife live off one paycheck and spend most of their resources supporting their disabled daughter. Unable to hire a tax preparer, they came to HCAP for the Free Tax Help program. The couple was overjoyed to find out they qualified for a Federal tax return of \$4,418, including \$3,050 from the EITC. With these refunds, they'll be able to catch up on all their bills and pay their daughter's much-needed medical costs.







Marko's Story: Former HCAP client inspires fellow veterans

Marko Johnson has made mistakes in his life, but through HCAP's support and his own ambition and hard work, he has turned his life around. Now he inspires others to do the same.

Marko came to HCAP's Central District Center in October 2009 for help finding a job. At that time, he was incarcerated and making the challenging transition back into the community with the help of Waiawa Correctional Facility's work furlough program. HCAP's staff remembers Marko as positive, motivated and goal-driven, and ready to make the changes he needed to make in order to move forward. HCAP helped Marko with job readiness training, gave him bus passes so he could go on job search, and helped with his job applications. After fulfilling his work furlough requirements, Marko got a job and started working again.

Now, almost two years after he came to HCAP, Marko is on the other side of the profession. As a case manager for the United States Veterans Initiative (U.S.VETS), he helps veterans find housing, jobs and social services. Marko is grateful that he can use his own experiences to educate, support, and inspire other veterans to work towards a more hopeful future.

Head Start brings the outdoors, indoors

HCAP Head Start preschoolers have been getting their hands dirty as they learn by experience about the natural world. At Head Start Wahiawa Pre Plus, Ms. Dona and the kids created a terrarium with recycled materials and placed leaves, water, and other bugs inside. They also constructed raised flower

teachers and students consider their garden an "outdoor classroom." The kids enjoy helping with the garden and feel so proud to harvest eggplant, radishes, sweet potato, beets and herbs to share with their families. They also get a hands-on education about sustainability and eating healthy.

Other organizations also lend their support to the children's education. This year, students from Head Start Heeia and Keolu took a field trip to Kualoa Ranch, where they learned about aquaculture. Also known as aquafarming, the children learned that aquaculture is the farming of fish, crustaceans, mollusks and aquatic plants, under controlled conditions. They loved seeing how the fish and plants helped each other.



Making ends meet: Seniors get relief from rising utility costs

Donald Hall and his wife live on a limited income due to their high medical costs. When they found out about HCAP's Weatherization Assistance Program, they took a chance and inquired, even though they had never qualified for this type of program before. The Halls own a home, but their income had been cut significantly and they were worried about keeping their home. It had became more and more difficult for them to keep up with increasing water, sewage and electric costs.

"We were stuck in the mud," says Mr. Hall. "I'm 66 years old and have never been in the 'help system' before. I didn't know how to navigate the system or get help."

HCAP's team made the application process simple and easy for the Halls, who received free CFL light bulbs, energy education tips, and a new water heater. It was just in time, says Mr. Hall. "When the tank was removed, we learned that the rods were corroded and the old tank was about to die. We were very blessed with the timing of the program and all we received."

"I am very frugal and always intend to conserve energy," says HCAP client Kaaka Lowe, "But this program really got me to follow through."

Mr. Lowe found out about HCAP's Weatherization Assistance Program through a notice in the Hawaiian Electric Company newsletter. It caught his eye, he says, because he had wanted a solar water heater but there was no way he could afford it on his own.

With his grandchildren staying with him for the summer, Mr. Lowe's utility costs were high, and he qualified for a free home energy audit and a hybrid/heat pump water heater through HCAP. "I am so happy with the whole thing!" he says.

Now, he says, he follows his family around the house, to make sure they turn off the lights. Mr. Lowe recommends this program to other households who are looking for ways to "save electricity, save energy and wean us off foreign oil."







